The factory is vertically integrated from fisheries, which guarantees control and full traceability.

All the crude oil used in Golden Omega®'s production has been verified by Orivo as Pure Anchovy from the South Pacific

Manufacturing Process

Strategic Location

The production facility is located in the northern Chile just besides the fisheries, in the middle of the richest fishing ground worldwide.





Golden Omega[®] is vertically integrated from fisheries which guarantees control over the supply chain and full traceability from the fishing to the final Omega-3 product.

State-of-the-art Facility

Golden Omega[®]'s facility has the latest available European technology for the processing of Omega-3 oils. The production facility includes the area for the novel patented **Selective Crystallization** concentration technology which has been fully developed by Golden Omega[®]'s R&D team.

Pilot Plant

The pilot plant is a replica of the commercial plant and allows Golden Omega[®] to develop customized products and continuously improve the processes and quality of the fish oil concentrates.

R&D Orientation

Golden Omega[®]'s R&D department has a vast experience in the processing of Omega-3 fatty acids, materialized in **three international patents** (US8258330, US8586772 y US8957231):

US8258330: Carrier fluid composition comprising fatty acids ethyl esters and process for reducing the concentration of persistent organic pollutants in fish oil.

US8586772: Method for producing a concentrate of eicosapentaenoic and docosahexaenoic acid esters.

US8957231: Concentrate of Omega-3. An efficient and simple process to obtain a concentrate that includes over 80% in weight of ethyl esters of Omega-3 fatty acids.



Quality Assurance

Golden Omega[®]'s novel patented purification process (Second Generation Stripping

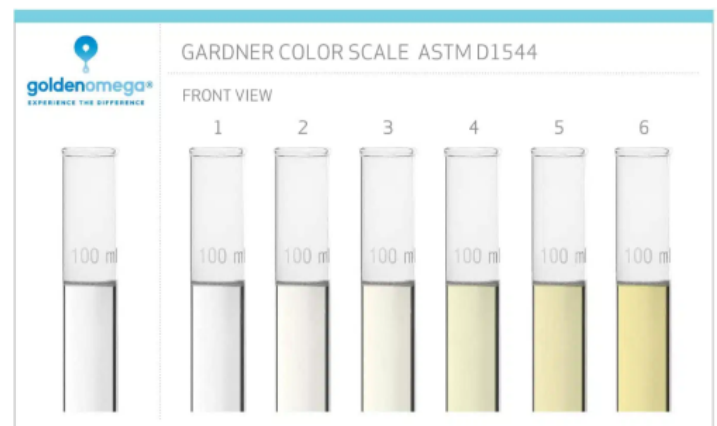
Technology) and the fact that they use Pure Anchovy from the South Pacific (Orivo verified), allow Golden Omega[®] to offer fish oil concentrates with very low levels of contaminants and pollutants.

Golden Omega[®]'s typical values for these contaminants are significantly lower than the maximum levels set by the GOED Voluntary Monograph or EU directives for these fish oil products.

Furthermore, short transportation routes and the freshness of the starting material are two key aspects for Golden Omega[®]'s excellent sensory profile. Golden Omega[®]'s Omega-3 concentrates are extremely low in peroxide value, p-anisidine value and TOTOX (typically 3-5), far below the maximum values set up in the GOED Voluntary Monograph.

Extremely clear Omega3 concentrates

The EE concentrates are Gardner colour 1.5 or below, and the TG concentrates are Gardner colour 2 or below. This is due to a novel R&D development which allows Golden Omega[®] to remove in a much deeper way some unwanted compounds in the oil.



Certifications

Golden Omega[®] holds a wide range of globally recognised certifications and memberships that ensure quality, sustainability, and safety in its omega-3 products:

- **ORIVO:** Certification verifying that the crude fish oil used in Golden Omega[®] production is pure anchovy sourced from the South Pacific.
- **IFOS (International Fish Oil Standards):** Rigorous third-party testing program that certifies omega-3 products for purity, potency, and compliance with international standards.
- **GOED (Global Organization for EPA and DHA Omega-3s):** Golden Omega[®] is a proud member of GOED, a global trade association committed to advancing quality, safety, and accurate labelling in the omega-3 industry.
- **Friend of the Sea:** Certification ensuring responsible management of wild



fisheries and aquaculture, promoting sustainable marine practices.

- **Marin Trust:** Certification guaranteeing responsible, traceable and sustainable supply chains.
- **NSF (Good Manufacturing Practice Certification):** Independent verification ensuring Golden Omega's facility meets strict cGMP standards for dietary supplement manufacturing.

Sustainability

Golden Omega maintain an ongoing, long-term commitment to environmental protection and the sustainable management of resources. This includes actions that exceed compliance with current regulations, as well as active cooperation with national authorities and organizations.

From Sustainable Sources

Golden Omega produces all its Omega-3 concentrates exclusively from Pure Anchovy in the South Pacific with minimal impact on biodiversity earning their fish oils various certifications.

Environment Protection and Eco-Friendly Operations

- The production unit is close to the fisheries therefore, there is no need for transportation of the crude oil. Golden Omega assembles their own drums at the facility which saves 90% transportation of drums.
- Their production process generates zero oil waste. Any oil fractions not used in their final products are sold as by-products for various industrial applications.
- Golden Omega's facility in northern Chile is powered entirely by 100% clean and renewable energy, demonstrating their commitment to sustainable operations and a greener future.

- Golden Omega have built the first seawater desalination plant. This allows them to secure a stable water supply and cut Arica's potable water usage by more than 6,500 people's daily consumption

Social Responsibility

Golden Omega's Community Engagement Strategy included:

- **Educational Partnerships:** Collaborated with local technical and university institutions to design relevant curricula and offer internships, supporting economic diversification and preparing the workforce for high-value jobs.
- **Environmental Stewardship:** Launched "Zero Plastic Waves" with NGOs and municipal authorities, featuring beach clean-ups and marine conservation workshops to protect the South Pacific environment.
- **Sports & Healthy Living:** Sponsored local surf and bodyboarding events to promote active lifestyles.

Approved Health Claims

The following health claims for EPA and DHA have been approved by EFSA (Commission Regulation (EU) 1924/2006 and 432/2012):

DHA and EPA

- Normal function of the **heart** (0.25 g per day)
- Maintenance of normal **blood pressure** (3 g per day)
- Maintenance of normal **blood triglyceride levels** (2 g per day)

DHA

- Maintenance of normal **brain function** (0.25 g per day)
- Maintenance of **normal vision** (0.25 g per day)

DHA maternal intake

- Normal **brain development of the foetus and breastfed infants** (0.2 g DHA plus the daily recommended intake of omega-3 fatty acids (EPA+DHA for adults which is 0.25 g per day).
- Normal development of the **eye of the foetus and breastfed infants** (0.2 g DHA plus the daily recommended intake of omega-3 fatty acids (EPA+DHA) for adults which is 0.25 g per day).
