Quality Assurance

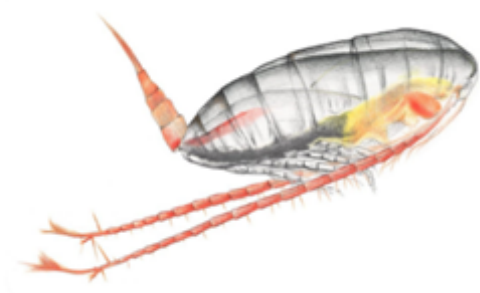
A novel, patented purification process (Second Generation Stripping Technology) and ORIVO verified sourcing (pure anchovies from the South Pacific, which are known to have a shorter lifespan than other fish species) enables Golden Omega® Fish Oil Concentrates to achieve exceptionally low levels of contaminants and pollutants.

Because Calanus is a tiny organism with a short, 1-year life cycle, the levels of toxins and pollutants do not have time to accumulate. The oil is unrefined and extracted without the use of chemicals, ensuring a natural and unprocessed product.

Sustainability

Calanus, a type of zooplankton found in the Norwegian Sea, is a highly sustainable and environmentally friendly marine resource. Each year, the Calanus population naturally regenerates an estimated 290 million tonnes of biomass.

From this vast renewable supply, only 0.0005% is carefully and responsibly harvested to produce Zooca® Calanus® Oil. The product is certified by both MarinTrust® and Friend of the Sea®, reflecting its compliance with rigorous sustainability and environmental standards.

They are also Friend of the Sea®, Dolphin Safe® and MarinTrust® certified for responsible fishing.



Product Safety

Zooca® Calanus® Oil is recognised as safe and is **Novel Food approved** in Europe at a maximum level of 3.1g per day.

The levels of contaminants in all Golden Omega® Fish Oil Concentrates are far below the established EU regulatory guidelines.

Product Dosage

One capsule (1000mg) of ZOΩ3GO™ benefits from the EPA and DHA Approved EFSA Health Claim related to **Cardiovascular Health** with the additional benefits found from all the research conducted on Zooca® Calanus® Oil for **metabolic health¹** and **healthy aging¹**.

Additionally, ZOΩ3GO™ also benefits from the Vitamin E Health Claim on "Protection of Cells from Oxidative Stress" as the amount of d-alpha-Tocopherol contained in 1000mg is above the minimum threshold required to use this claim.

Furthermore, with 2 capsules a day (2000mg) customers can meet the DHA Approved EFSA Health Claim related to **Brain and Eye Health** with the additional antioxidant benefits of **astaxanthin and marine policosanols** from Zooca® Calanus® Oil.
