- The production unit is close to the fisheries therefore, there is no need for transportation of the crude oil. Golden Omega<sup>®</sup> assembles their own drums at the facility which saves 90% transportation of drums.
- Their production process generates zero oil waste. Any oil fractions not used in their final products are sold as by-products for various industrial applications.
- Golden Omega<sup>®</sup> received the Green-e<sup>™</sup> certification for the use of 100% clean and renewable energy in its facility based in the north of Chile, from Centre for Resource Solutions (CRS).
